APPLICATION INSTRUCTIONS

APPLICATION METHOD / TOOLS

According to common practice on site, the Sika Waterbar[®] O D.Wall VN is placed to suit the concrete movements in expansion joints. The connections are done by heated blade welding technique.

Sika Waterbar[®] O D.Wall VN is made by thermoplastic PVC and therefor can be welded. The cut sections are subject to welding are heated up by means of the welding blade until the material gets plastic, and then pressed together.

Installation

The center of Sika Waterbar[®] O D.Wall VN should be at the concrete joint and at the center of concrete thickness. Steel wires can be used to secure Sika Waterbar[®] O D.Wall VN in place before pouring the new concrete.

IMPORTANT CONSIDERATIONS

- Level differences, bends, junctions, etc. should be carefully considered before placing.
- Care should be taken to avoid breathing fumes and smoke during the PVC welding process. Hence, welding should be performed in open, well ventilated area.
- In case of doubt always follow the directions given on the pack or label.
