SUBSTRATE QUALITY / PRE-TREATMENT

The substrate must be free from loose and friable particles, dust and dirt. Remnants of release agents, particularly oil and wax based, must be removed. SikaTop® or Sika MonoTop® mortars can be overcoated after 7 days.

APPLICATION

Sikagard®-670 WMY is supplied ready to use. However, before applying, the material must be thoroughly stirred mechanically. Sikagard®-670 WMY can be applied by brush or roller (preferably with a short piled lamb skin roller) or airless spray equipment with a pressure of 180 bar, nozzle with opening diameter of 0.38–0.66 mm and a spraying angle of 50–60°.

CLEANING OF TOOLS

Clean all tools and application equipment with water immediately after use. Hardened or cured material can only be mechanically removed.
